

Liaison Committee Changes in 2023

The AANR-Florida Board held its Mid-winter Meeting on January 7<sup>th</sup> at Suwannee Valley Resort. Many thanks to BG and her staff who did a great job welcoming all of us and making us comfortable through a very cold (well, North Florida cold) weekend.

One topic of business was the Club Liaison Committee. The Board agreed that the Committee needs to increase its presence and encourage greater interaction between the liaisons and their individually assigned clubs and resorts.

According to the established Procedural Manual, the purpose of the Club Liaison Committee is first and foremost to provide open, speedy, and personal communication between AANR-Florida club leaders and members and AANR-Florida officials.

This communication is to include sharing best practices in areas such as club operations and public relations while recognizing that each club has its own special identity. It is also the means of ensuring awareness of the benefits that clubs are entitled to receive.

The Committee is responsible to share information and offer support for the formation of new clubs and work with the AANR office to help new clubs become chartered.

Other support incudes contacting affected clubs that may be impacted by natural disasters to offer the support of AANR-Florida. We have seen first-hand in recent years how important this is.

All club liaisons have been trained on the procedures and purposes of the Committee. The Board believes that a more open and supportive approach with the clubs may help to establish stronger and more mutually beneficial relationships.

All club managers/owners will be contacted by their assigned liaison to mutually determine the best way for your liaison to support you. Please give this some advanced thought to be able to share your ideas. The expectation is that the liaison will make a *minimum* of two contacts with you per year, with hopefully at least one being an in-person visit.

# Governmental Affairs 2023 Monitoring Florida Interim-Committee Meetings & Regular Legislative Session

#### **Legislative Issues and Priorities**

#### Monitor "Grooming" Legislation

Florida Governor Ron DeSantis and the overwhelmingly Republican Legislature have taken issue with sexually explicit sex and gender education being pushed in Florida public schools, primarily between k-3<sup>rd</sup> grade, priming children for abuse by allowing such instruction pushing them to question their gender identity and sexualizing children.

#### Monitor Legislation Where the Alcohol Sales, Nude-Recreation, and Children Are Involved

Florida Law Chapter 562, prohibits serving, selling, or allowing alcohol to be served to anyone under 21 and is a misdemeanor in the second degree. As part of the "woke" and "grooming," the Legislature may look into curbing or prohibiting the sale of alcohol where nude recreation, adults, and children are in the same environment in the same manner where clubs that allow full nudity sometimes are prohibited from selling alcohol.

. It would behoove every resort and club to create and implement a viable action plan addressing Parent and Club responsibilities to pre-empt unwarranted legislation.

#### **Support Beach Renourishment**

Governor DeSantis continues his commitment to environmental preservation, restoration, and spending. After Hurricanes Ian and Nicole devastated the state of Florida, several counties suffered extensive or devastating beach erosion including, Lee, Collier, Volusia, and Duval among the worst impacted.

Beach restoration is critical to Florida for many reasons: tourism, private property protection, environmentally sensitive lands, turtle nesting, and better health. In previous years, we fought to preserve beach renourishment and secured three years running \$50M per year.

This year, however, environmental preservation groups are questioning in Washington and in coastal states the practice of sand dredging and its impact on the ecosystem. A balance will have to be reached between the interests of the state and the environment this year to properly balance the best interest of both. Beach renourishment is critical to all coastal areas including Haulover, Blind Creek Beach, and every other beach where nude recreation takes place.

#### Support and Prevent Plastic Pollution

Each year 7000 tons of wasteful plastic pollution enter the ocean in Florida posing a major threat to our marine environment and coastal economy. State pre-emption on the regulation of most plastics prevent meaningful regulatory action to curb marine plastic and its negative impacts. A coastal plastics regulation pilot bill, intentional balloon release repeal, repeal of state pre-emption on the regulation of most plastics may be a way to begin the much-needed discussion, not just nudists and eco-friendly citizens conducting yearly beach clean-ups.

#### Support the Protection of Clean Water and Public Health

Sewage spills and stormwater runoff threaten the health of beachgoers, coastal ecosystems, and economies. Consistent water quality monitoring and public notification is needed to protect public health and inform solutions, while significant investments are needed to repair, upgrade, and ensure the climate resilience of Florida's failing water infrastructure. We must encourage and support the Florida Department of Health appropriation of \$500,000 for the "Florida Healthy Beaches Program, Safe Waterways Act, and implementation of Blue-Green Algae Task Force recommendations.

#### **Support Resiliency Solutions**

Florida's coastal communities, infrastructure, and marine ecosystems are increasingly threatened by sea level rise, extreme weather events, and flooding. State leadership is needed to implement sea level rise solutions that advance coastal resilience, protect coastal and marine habitats and communities, and harness

the power of nature to protect and prepare Florida's coasts from flooding and sea level rise by supporting the "Resilient Florida Grant Program," and implementing CS/HB7053.

May you have a safe and healthy month ahead of you and we will look forward to those of you that are attending the AANR Board meeting at Lake Como on the  $3^{\rm rd}-5^{\rm th}$  of February.

#### February is an exciting time at Sunsport.

The Midwinter Naturist Festival, February 16-21, is Sunsport's and the Naturist Society Foundation's largest event of the year. Sunsport will be full of naturists from all over North America to choose from over 210 scheduled activities. Favorites Armand and Angelina and Faerie Elaine will return. Drum circles, live entertainment, and movies happen each evening, four or five workshops every hour daytimes, and trips to clothing-optional beaches on Tuesday. There will also be skin cancer screening available Saturday. The restaurant will be open for three buffet-style meals daily. You can find the updated full Festival program including a description of each workshop on Sunsport's and the Naturist Society Foundation's websites.

Sunsport members who lead at least two workshops or volunteer to help for at least five hours will have their registration fee waived. Those wishing to volunteer in the restaurant, at the hospitality booth, in the office, checking showers and restrooms, moving chairs, or parking cars should attend a volunteer meeting Wednesday, February 8th, at 8 pm in the pavilion.

Anyone registered for the Festival may set up a booth at no charge in Vendor/Practitioner Row as early as 9 am on Wednesday, February 15th. Vendors and practitioners must supply their own tables, chairs, canopies, etc. as desired. These booths help to enrich the Festival experience.

While at the Festival, check out the beautiful Serenity Garden which now has a Budha statue surrounded by flowers, a pond with a waterfall, and a new Zen Garden.

There will be a Community Drum Circle on Friday, February 3rd.

The Annual Coed Fun Bowl Volleyball Tournament will be on Sunday, February 26th. To register for the

volleyball tournament, sign up at the volleyball court any afternoon with a \$5 entry fee. All skill levels are mixed with teams made up of different people each game.

Ongoing activities include Water Aerobics Monday, Wednesday, and Friday mornings at 10 am, morning pickleball, line dancing Tuesday at 9:30 am, yoga Thursday at 10 am, daily afternoon petanque and volleyball, and Saturday evening dances.

The Permaculture Committee led by Geoff Farmer organized a project to remove invasive green salvinia from the surface of the pond near the clubhouse. Fifteen people spent over 2 hours using boats to move the salvinia to the dock where a crew put into buckets. The salvinia was moved to the community garden area where it will make excellent fertilizer. Thanks to all the Sunsport members and guests who helped.

The office now has a variety of Sunsport Gardens T-shirts available. The shirts have attractive designs by Christopher Vuk.

Although Sunsport's legal name is Sunsport Gardens Inc., we use the title Sunsport Gardens Family Naturist Resort. The Family part is important. There is a family with three generations residing at Sunsport plus many other children. But that's not all. Children are welcome at all activities at Sunsport. Our Midwinter Naturist Festival is the only large event sponsored by a national naturist organization that has a full schedule of activities designed to interest children. Sunsport's July Family Youth Gathering is a wonderful experience for children with parents encouraged to participate with their children. Sunsport employs several young adults. I am proud that Sunsport provides a safe, healthy resort and community for families.

Reminder: Please use the appropriate containers for throwing out items.
