The month of June brings a reminder that we are now accepting nominations for three open positions to the AANR-Florida Region Board of Directors.

- Each Board member is elected for a two-year term and can be re-elected.
- An individual can be nominated or self-nominated.
- Board members must be a member in good standing for two (2) years immediately preceding nomination who, at the time of nomination, holds an AANR membership through an AANR-Florida Regional club or who is a Direct Member of the Florida Region.
- All AANR-Florida Regional Board members must have an official place of residence that is within the geographical boundaries of the AANR-Florida Region or no more than 100 miles from the AANR-Florida Regional boundaries of Florida, the Caribbean, and Eastern Mexico.
- The Board of Directors conducts the business of AANR-Florida Region during the period between summer and mid-winter meetings of the Regional Assembly.

- Questions and completed application forms should be submitted to Jonathan Duffield at jonathan.duffield@aanr-florida.org.
- Nominations are accepted up to nominations from the floor at the Regional Assembly.

All candidates will be asked to briefly present why they are interested in serving on the Board at the 2025 Regional Assembly hosted by Lake Como Family Nudist Resort in Lutz, Florida. Candidate presentations and voting will occur on Saturday, June 7th. Newly elected Board Members are expected to stay for meetings on the morning of Sunday, June 8th.

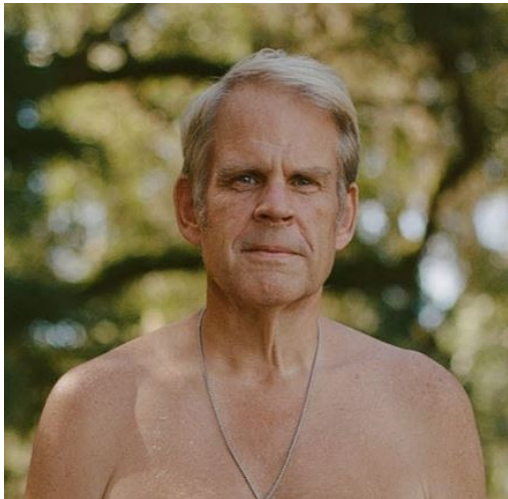

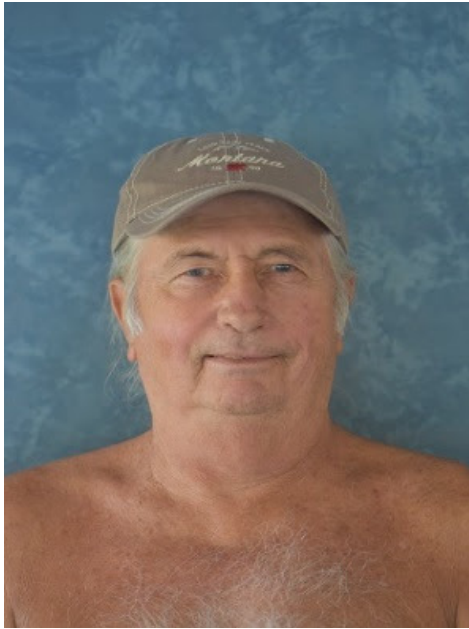
