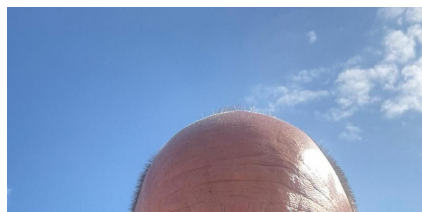

It is also important to note that August has additional special meanings to our nudist community. August is Nude

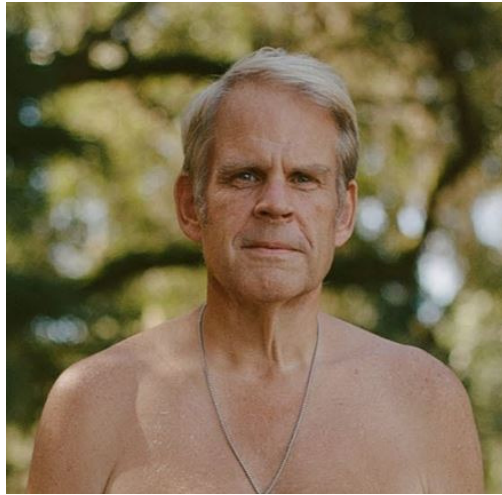
History Month. And the AANR Team has done a great job of telling the story and significance of this month. Please take some time to review these [publications](#).
